4. As between the exhibitor and the producer, the producer shall have the final authority to determine the location of the exhibitors display within the show and the exhibitors compliance with the aforesaid rules, regulations and policies.
5. Once the exhibitors display and/or vehicle or set up at the show, they shall not be removed or concealed by the exhibitor prior to the end of the show without permission of the producer.
6. Neither the producer, the sponsor, nor any officer, director or shareholder, therefore, or the owner of the building/grounds at watch the show is produced, shall be responsible or liable for any loss or damage to all or any part of the exhibitors personal property, which shall specifically include, but not be limited to exhibitors vehicle, trailer, display, material and /or parts, and the exhibitor hereby waves any and all rights it may have against them or any of them for such loss or damage. The exhibitors agree to obtain insurance covering the above

- and assumes full responsibility for any loss or damage. Exhibitors agree that this signed entry supersedes any and all prior/or contemporaneous agreements and understandings whether written or oral between exhibitor and the producer, it's employees, staff, representatives and sub-contractors or partners. Nothing here and shall be modified unless consented to by the producers in writing. Both parties agree all disagreements will be decided by arbitration in the state where the show is produced.
